INFORMATION FOR THE STUDENTS WHO HAVE TAKEN ADMISSION ON THEIR OWN IN PROFESSIONAL STREAM COURSES ON MERIT BASIS IN IITS / NITS / CENTRAL UNIVERSITIES CLAT AND IN GENERAL STREAM COURSES (SUBJECT TO CUET) IN DELHI UNIVERSITY / JAMIA UNIVERSITY / ALIGARH MUSLIM UNIVERSITY AND OTHER CENTRAL UNIVERSITIES ACADEMIC SESSION 2023-24.

Counselling Process for Special Scholarship Scheme for UTs of J&K and Ladakh (SSSJKL) under Pradhan Mantri Uchchatar Shiksha Protasahan Yojna (PM-USPY) – Academic Session 2023-24 is in process. Students who are already registered on the SSS JKL portal and have taken admission **on their own** in the Colleges of Delhi University, Aligarh Muslim University, Jamia Millia University & other Central Universities after qualifying CUET Examination and in IITs / NITs / CLAT (Except J&K and Ladakh) are required to upload their proof of admission like joining letter / fee receipt etc. to the "Entrance Exam Tab" on the SSSJKL Portal after completion of counselling process by PM-USPY SSSJKL AICTE w.e.f. 20.09.2023.

The students who want to take admission in Indian Institute of Space Science & Technology (IIST), Thiruvananthapuram will have to qualify JEE Advance 2023 conducted by IITs and secure the minimum prescribed marks (please see the link of IIST: https://bit.ly/3BgkbCy for detailed information). The students will send the details of results to AICTE on email jkadmission2023@aicte-india.org for onwards submission to IIST for finalizing the merit and only those students will be issued AICTE allotment letter for taking admission in IIST.

It is further informed that above students will be issued allotment letter on the basis of their admission taken "**on their own**" after due verification of their documents by the SSSJKL Cell, AICTE and they shall be eligible subject to norms of AICTE and availability of scholarship.
