1. AIMS & OBJECTIVES

The objective of the EOI is to select the best institution which shall establish and operate the ATAL- IDEA Lab at AICTE Camp Office in Jaipur. The Lab will serve as a model IDEA Lab for all technical institutions in the region/country.

2. BACKGROUND

AICTE has decided to establish an ATAL- IDEA (Idea Development, Evaluation & Application) Lab at its Camp Office in Jaipur, having setup one each in Visveswaraiah Technological University (VTU), Muddenahalli (Karnataka) & Deenbandhu Chhotu Ram University of Science and Technology (DCRUST), Murthal (Haryana).
