Sub: Online Counselling Process of PMSSS Students of the Union Territories of Jammu & Kashmir and Ladakh during Academic Year 2020-2021.

Sir / Madam,

The matter relates to the implementation of Prime Minister's Special Scholarship Scheme (PMSSS) for the students of UTs of J&K and Ladakh during Academic Year 2020-21.

In this context, it is informed that the AICTE is likely to conduct online counselling for aspiring students who have registered themselves on AICTE Portal and have been declared eligible under the Scheme by J&K and Ladakh Govt. in the end of October, 2020. The meritorious students may be issued allotment letter with a copy to Principal / Nodal Officer of the respective institute as per the choice provided by the students.

In view of COVID-19 Pandemic, the students who will be allotted seats during current academic session may not be able to join the institution physically due to the non-availability of transport facilities and other preventive measures taken by the Ministry of Home Affairs, Govt. of India from time to time.

It is, therefore, decided that the allotted student(s) under the Scheme may be permitted to join the respective institution through online mode. The institution will also complete all the admission formalities of the student and verification on AICTE Portal online within the prescribed date as mentioned in the allotment letter of the student.

In this context, it is proposed that only academic fee shall may be released to the institution after getting confirmation from the respective institution that the students(s) are studying through online mode. As and when, the students will physically report to the institution and confirmation to this effect is provided by the institution on AICTE Portal, the maintenance charges will be disbursed to the students as per the norms.


You are requested to provide all necessary help to the PMSSS Students in joining the institution / course through on-line mode and help the student during this COVID-19 Pandemic period.
