**Sub: Extension in joining time by the student of J&K State upto 30<sup>th</sup> September, 2017 under Prime Minister's Special Scholarship Scheme (PMSSS) for the Academic Year 2017-18.**

Whereas, the Hon'ble Supreme Court of India vide judgement dated 12<sup>th</sup> September, 2017 in the case of Parshavanath Charitable Trust and others v/s AICTE & others (2013) 3 SCC 385 has directed that no student should be admitted in any Institution by AICTE after 15<sup>th</sup> August of the academic year under any quota; and

Whereas, in view of present situation in the State, 2<sup>nd</sup> and subsequent round of counseling for the students of Jammu & Kashmir State for securing admission in the Colleges / Institutions outside the State under Prime Minister's Special Scholarship Scheme (PMSSS) was conducted by the All India Council for Technical Education (AICTE). The last date for admission of the candidates is 15<sup>th</sup> August every year as per the orders passed by Hon'ble Supreme Court of India in the matter Parshvanath Charitable Trust & others v/s AICTE in C.A. No. 9048/2012. Now, the Hon'ble Supreme Court of India is pleased to pass the following orders for PMSSS Students admitted during academic year 2017-18:

**" For the reasons stated in the application time for admission of students is extended upto 30.09.2017"**

Therefore, all those candidates, who will be possessing provisional admission letters from AICTE under PMSSS 2017-18 are now hereby informed to join their respective Colleges / Universities on or before 30<sup>th</sup> September, 2017. All the Institutions / Universities are also advised to facilitate students in joining.

Since, the classes have already begun, students are advised to join the Colleges immediately without wasting time.

Whereas, the Hon'ble Supreme Court of India vide judgement dated 13.12.2012 in the case of Parshavanath Charitable Trust & Others Vs AICTE & Others has directed that no student should be admitted in any Institution by AICTE after 15<sup>th</sup> August of the academic year under any quota; and

Whereas, in view of present situation in the State, 1<sup>st</sup> round of counseling for students of J&K State for securing admission in the Colleges/Institutions outside the State under Prime Minister's Special Scholarship Scheme (PMSSS) was conducted by All India Council for Technical Education (AICTE) from 30.06.2017 to 06.07.2017 and 17.07.2017 to 18.07.2017.

Whereas, the 2<sup>nd</sup> round of counseling was conducted from 04.08.2017 to 07.08.2017, 3<sup>rd</sup> round of counseling was conducted from 09.08.2017 to 11.08.2017 and 4<sup>th</sup> round of counseling was conducted thereafter;

Whereas, in view of above position, the State Government submitted an application before the Hon'ble Supreme Court for grant of extension in joining time of candidates belonging to J&K State upto 30<sup>th</sup> September, 2017; and

Whereas, the Hon'ble Supreme Court while disposing off the said application in IA No. 89915 of 2017 in Civil Appeal No. 9048 of 2012 was pleased to pass the following orders:-

*"For the reasons stated in the applications time for admission of students is extended upto 30.09.2017.*

*The applications are disposed of accordingly."*

Now, therefore, all those candidates, who have received provisional admission letters from AICTE under Prime Minister's Special Scholarship Scheme (PMSSS) and are yet to get their admission in the allotted Colleges are hereby informed to join their respective Colleges by or before 30<sup>th</sup> of September, 2017.
