Whereas, the Hon'ble Supreme Court of India vide judgement dated 13-12-2013 in the case of **Parshavanath Charitable Trust and others Vs AICTE & others** (2013) 3 SCC 385 has directed that no student should be admitted in any Institution by AICTE after 15th August of the academic year under any quota; and

Whereas, in view of present situation in the State, 2nd round of counselling for the students of J&K State for securing admission in the Colleges/ Institutions outside the State under Prime Minister's Special Scholarship Scheme (PMSSS) was conducted by the All India Council for Technical Education (AICTE) at National Institute of Technical Teachers Training & Research (NITTR) Chandigarh on 13-08-2016 and last date for admission of the selected candidates was fixed on 15-08-2016. However, it was extremely difficult for the candidates to get their admissions in the allotted colleges, in a short period of time and prevailing situation in the valley; and

Whereas, in view of above position, the State Government submitted an application before the Hon'ble Supreme Court for grant of extension in joining time of candidates belonging to J&K State upto 30th September, 2016; and

Whereas, the Hon'ble Supreme Court while disposing off the said application in IA No: 100 of 2016 in Civil Appeal No: 9048 of 2012 was pleased to pass the following orders:-

"Heard learned counsel for the applicant. For the reasons stated in the interlocutory application, time sought for is extended upto 30<sup>th</sup> September, 2016".

## Accordingly, I.A No. 100 of 2016 is allowed.

**Now, therefore,** all those candidates, who have received provisional admission letters from AICTE under Prime Minister's Special Scholarship Scheme (PMSSS) and are yet to get their admission in the allotted Colleges are hereby informed to join their respective colleges by or before 30<sup>th</sup> of September 2016.
